**III. Consideration of Proposals and Amendments**

**a) Infinity Labs, LLC – (Amendment)**

*The company is requesting \$25,436.84 for 1 trainee. The position is a high wage job and is*

*eligible for an additional 5% reimbursement.*

A motion to approve this request was made by Kelley Allen and seconded by Michelle Doran. Motion passed unanimously.

**b) Franklin Mountain Packaging – StepUp –**

*The company is requesting \$26,250.00 for 2 trainees. The company is requesting funds for trainees in their Safe Quality Food.*

A motion to approve this request was made by Kelley Allen and seconded by Kathleen Sena. Motion passed unanimously.

**c) Securin, Inc. – StepUp -**

*The company is requesting \$9,498.50 for 3 trainees. Securin has been approved for JTIP on three previous occasions, this is the first StepUp application for the company. Securin is requesting funds for training the three employees in OffSec Services Limited, OffSec Learn Enterprise Subscription.*

A motion to approve this request was made by Marc Duske and seconded by Kelley Allen. Motion passed unanimously.

**d) Securin, Inc. -**

*The company is requesting \$470,467.40 for 10 trainees. Securin has been approved for JTIP on three previous occasions. These positions are high-wage jobs and are eligible for an additional 5% reimbursement. The positions are as follows: Customer Success Manager, Intern Security Analyst, Engineering Director, IT Systems Admin, Sales Engineer, Security Analyst, and Director of Product.*

**e) UbiQD, Inc -**

*The company is requesting \$139,729.52 for 5 trainees. UbiQD has been approved for thirteen previous occasions. These positions are high-wage jobs and are eligible for an additional 5% reimbursement. The positions are as follows: R&D Tech, Engineer, IT Manager.*

**f) Stampede Culinary Partners, Inc. – Stampede Meat**

*The company is requesting \$455,830.00 for 80 positions. Stampede Meat has been approved for JTIP on nine previous occasions. The Maintenance Technician positions are high wage jobs and are eligible for an additional 5% reimbursement. The positions are as follows: Administrative Clerck, Assistant Supervisor, Forklift Driver, Machine Operator, Maintenance Technician, Packer/Meat Handler, Trimmer, Walkie-Driver, Quality Control Technician.*

A motion to approve this request was made by Michelle Doran and seconded by Marc Duske. Motion passed unanimously.

**g) Turquoise Skies -**

*The company is requesting \$156,170.00 for 6 trainees. This is Turquoise Skies first JTIP application. The positions are as follows: Inventory Flow and Wholesale Account Management, Jewelry Lost wax casting specialist, Wax Sculpting and soldering Assistant, Jewelery Silversmith, and Jewelry Prototyping Specialist.*
